"CONFIDENTIAL INFORMATION" includes all information which relates to Black Hills Service Company, LLC's or Transporters' past, present, and future research, development, and business activities. This includes, but is not limited to, computerized data, methods, techniques, and documentation relating to QPTM. All confidential information is considered proprietary in nature. You may not reproduce, disclose or otherwise make any confidential information available to any other company, corporation or individual.

Your USER ID and password are confidential and are intended for your use **only**. Your USER ID and password identify your company and function(s) related to QPTM access. You are not allowed to disclose your USER ID and password to anyone. They uniquely identify you. You will be held responsible for any security breach traceable to your USER ID and password.

You should request that Black Hills Gas, LLC change your USER ID and password whenever you suspect that an unauthorized person may know your current USER ID and password.

Use of QPTM is restricted to transactions with Black Hills Service Company, LLC and approved Black Hills Service Company, LLC-operated pipelines.

You may access only data for which you have specific authorization. You may **not** access the data of subsidiaries, affiliates or companies for whom you have an agency relationship unless **supporting legal documentation** (Delegation Form) has been provided to Black Hills Service Company, LLC. All access attempts, both successful and unsuccessful, are recorded.

USER IDs that are inactive for 90 days may be automatically suspended. If your USER ID is suspended, you must contact Black Hills Service Company, LLC's QPTM personnel to have your USER ID reinstated. Your USER ID is issued to you on the agreement that you are representing the shipper you stated on the front of this form. You may not use this USER ID to access QPTM if you leave the employment of the company that you stated.

Users who violate the terms of this **ACKNOWLEDGMENT OF RESPONSIBILITY** may be subject to legal action appropriate to the severity of the violation.
